

TERMS AND CONDITIONS

Organisation and Principle of the Prize Draw

1. This prize draw ("Prize Draw") is organised by Rezidor Hotels UK LTD and designed for professional meeting planners, whether acting as individuals or on behalf of a legal entity which is active in the meetings and events industry and are domiciled in the United Kingdom and Ireland.
2. The competition starts on the 7th of October 2016 and ends on the 20th of December 2016.

The mechanics of the competition:

3. Participants must be members of the Club Carlson SM programme to take part in the prize draw and to be eligible to win the prize.
4. Participants must answer to the 3 questions on the home page to get access to the enrolment form.
5. If the "Participant" holds a Club Carlson membership the membership number will have to be submitted on goldpoints-millionaire.carlsonrezidor.com (further referred to as the "Website") to have access to enrolment form.

Conditions
